## **Buckeye Premier Policy for Restarting a Match Suspended for Thunder or Lightning**

- If a match is in the **1st half** and there is a delay:
  - Upon the restart, extend the time of the 1st half to equal to at least ½ the standard length of a half for that age group.
  - If the first half has already exceeded the time to equal to at least ½ the standard length of a half for that age group, the referee should immediately go to half time. At the expiration of the mandated 30 minute delay, the 2<sup>nd</sup> half of the game should then start.
  - The length of the 2<sup>nd</sup> half should be the same time as the time actually played for the 1<sup>st</sup> half. Said alternately, each half will be played with equal time.
  - There can only be one delay per game. If a second delay is necessary, the match is terminated. If the match is terminated due to a second delay, the match will be considered as not having been played and should be re-scheduled
- Any match that has made it to half-time or after and there is a delay, the match will be considered a complete match. The match is over and the score stands. There should be no restart or continuation of the match.

## **MANAGING THE TOUCHLINES FOR ALL FUTURE BPYSL MATCHES PLAYED IN GREATER DAYTON**

Effective 10/01/19 & All Subsequent Seasons

**Officials please read carefully & completely. Should anything be unclear or you have questions please call me ASAP before your next match.**

We are all aware of our sport continuing to suffer attracting & retaining officials. We have now lost multiple experienced adult + numerous inexperienced officials in recent years. Why? Dissent & abuse from coaches, administrators, fans & too a significantly lesser extent players. As your assignor I am today drawing a bright wide line in the sand directing going forward without exception

Dissent during any BPYSL match played in greater Dayton in all physical & verbal forms is **TO STOP NOW - NO EXCEPTION!**

**"Ask Tell Remove":** We've all received this USSF guidance & training. Without exception, I expect each official will consistently apply this during all BPYSL matches played in greater Dayton.

### **Ask:**

First expression of physical or verbal dissent:

Coaches/players - The referee will politely warn verbally that there be no more dissent without consequences.

Fans - The referee will politely warn verbally that there be no more dissent without consequences. Make clear this applies to everyone, not just the source.

### **Tell:**

Second expression of physical or verbal dissent:

Coaches/players will be shown a yellow card.

Fans will be politely warned verbally this is the second & final expression of dissent without consequences. Make absolutely clear, "The next expression of dissent will result in a minimum of the offender leaving the touchline & being sent to their vehicle." The match will not restart until the referee is satisfied.

## Remove:

### Third expression of physical or verbal dissent:

Coaches/players will be shown either a yellow card and/or red card depending upon the type of dissent.

A player must exit the field in a timely manner & will not re-enter play. The player continues to be under the responsibility of the head coach.

A coach must exit the field in a timely manner & is sent to their vehicle.

- Collect & retain the player and/or coach card(s).
- Either a BPYSL or USSF post game report must be submitted to both the league & assignor within 24 hours.
- If a team has only (1) coach which has earned a send-off, BPYSL RULES permit a fan or other representative of the affected team to assume the role of coach using the card of the sent off coach as authority. The match continues until close of regulation play.

Fans - Politely approach the head coach associated with the fan to be removed & inform the head coach he/she must immediately remove the individual(s); they must exit the field in a timely manner & is/are sent to their vehicle. No protracted discussion is allowed. Play will not resume until the individual(s) has/have complied to the satisfaction of the referee.

- Either a BPYSL or USSF post game report must be submitted to both the league & assignor within 24 hours.

### Post-Match dissent:

Any form of physical & verbal dissent is to be reported to both the league & assignor within 24 hours Either a BPYSL or USSF post game report.

Coaches/players – Politely remind that the referee retains all control post-match & request the dissent immediately cease. If dissent continues, the referee will firmly but politely insist upon all cards being returned to the referee. Retain the appropriate card(s) before returning the balance. If the cards are not returned, clearly identify in your report a description of the person refusing to comply.

Fans - All fans continue to be under the responsibility of the respective head coach. Ask the head coach to intervene & document the response by the coach in your report.

### Referee Abuse & Assault

Carefully follow all USSF & OSSRC training.

Use your cellular telephone as you believe appropriate.

### Consequences for officials failing to strictly follow the above guidance:

Any official, irrespective of reason/excuse, failing to strictly follow the above guidance WILL have on an escalating scale future BPYSL matches taken away. With the strict application of the guidance above all future BPYSL matches playing in greater Dayton will have an environment conducive to enhanced player experiences.
